
THE MAKING OF

POTTED FEATHER FLOWERS

The pattern of Hong Kong's postwar industrial expansion has been determined by its position as a major world trading centre and by the influx of refugee labour, which together ensured that the typical Hong Kong industry should be producing low-cost goods for export. Concentration on a limited range of products and markets has bred instability. There is thus the need for diversification. For years Hong Kong industry has been concentrated on textiles, clothing and plastic products which accounted for almost three quarters of the 96 per cent increase in domestic exports and four fifths of the increase in recorded employment between 1956 and 1960. With the passing of time, the need for diversification is even more acute. To cope with this need, Hong Kong industrialists have therefore to exploit into every possible means to invent or create new industries. This does, in a way help Hong Kong to maintain its position as an ever developing industrial centre.

Recently, a new industry in Hong Kong was set up in response to the need for diversification. About four months ago, a Hong Kong company put on the market potted feather flowers. Soon the company was swamped with overseas orders. This industry — the making of potted feather flowers thus has





a firm footing in the Hong Kong industrial realm.

In fact, this making of feather flowers is not new at all. The French have been making them for 50 to 60 years for many sections of the garment trade. Hong Kong started first with the making of corsages, but this product got a poor reception because they were priced too high and could not compete with flowers made of fabrics. Then, attention was given to the making of birds - which did not do so well either. Now the making of flowers and foliage has taken place instead. Even this does not fare as well as was expected, until recently when an owner of a flower manufacturing company thought of putting the flowers in pots.

Demand came first from Australia, then from Japan, where the company was competing well against their local product, Canada and Britain.

The reason why this industry has caught the fancy of the public is that that flower arrangement can now be done with potted flowers. Ikebana has always been a popular art in Hong Kong, and the idea of getting the feather flowers arranged beautifully in pots is welcomed by buyers overseas. There are many ways of arranging the flowers which is a delicate art. Now the potted product means big business for Hong Kong.



To discuss Australian Customs

The Australian Embassy in Tokyo has advised the Chamber that Mr. R. G. Stewart, Customs Attache, will be visiting Hong Kong from 2nd February to 6th February, 1968 and will be pleased to see any of our members who may wish to Australian Customs discuss problems. Appointments may be made through the office of Australian Government the Trade Commissioner in Union House, Connaught Road, Hong Kong.

The Hong Kong Trade Mission to Australia in October 1967 had been very successful, especially in arousing business interests between the two territories. In order to promote our export to Australia, businessmen have to consider, besides other factors, the question of tariff and customs procedures. It is, therefore, hoped that members will take this opportunity to discuss these matters with Mr. Stewart during his stay in Hong Kong.

HK — best investment prospect in SE Asia

Many manufacturers believe that Hong Kong represents the best industrial investment prospect in South East Asia, according to a survey by the Commerce and Industry Department.

The reasons given included the skilful and hard working labour force, the highly developed banking and commercial infrastructure and a minimum of Government "red tape."

The availability of local capital and the case by which profits could repatriated were other factors which made Hong Kong such an attractive proposition to the overseas investor. "The general picture which emerged from the survey is one of confidence and continued industrial growth in Hong Kong."

Telco. reports record year

In 1967, the Hong Kong Telephone Company achieved an all-time record net gain in exchange lines of 45,113. This compares with a figure of 33,231 for the previous year. The net gain in telephones in 1967 was 52,238 compared with 40,198 in 1966.

On January 1, 1967, the waiting list for new lines stood at 38,490 and on December 31, 1967, this figure had been reduced to 28,623. The waiting list for telephone removals on January 1, 1967, was 3,230 and on December 31, 1967, it had fallen to 2,053.

On January 1, 1968, the company had 280,826 working exchange lines and 353,912 working telephones; this is equal to nearly 10 telephones per 100 population, the highest penetration figure of any country in the Continent of Asia, apart from Japan.

Chamber Scholarship



Mr. J. Llewellyn, Assistant Registrar of the Hong Kong University, introduced Mr. Lau Chun Kay, first year student of the Faculty of Engineering to the Hong Kong General Chamber of Commerce. The University considered many eligible candidates for the annual Chamber scholarship and the successful applicant was Mr. Lau, seen here being presented with a cheque from the Chamber by the Executive Director, Mr. Geoffrey Archer.

These Chamber scholarships commemorate the Chamber Centenary in 1961 when they were first started to help deserving students complete their University studies.

As well as offering financial aid to undergraduates, the Chamber maintains contact with its scholars both before and atfer graduation in order to help them progress and find suitable and useful places in the Hong Kong community and to develop into experienced and successful executives. The Chamber feels there are many opportunities for university graduates with business interests to develop and play a prominent part in the ever developing society of Hong Kong.

Music Examinations

The Chairman of the Hong Kong Schools Music Association announced that consequent upon devaluation both the Associated Board of the Royal Schools of Music and Trinity College of Music, London, have agreed to small reductions in the Theory and Practical examination fees for grades only during 1968.

Owing to the late arrival of application forms candidates who wish to enter the Associated Board March Theory examination are advised to obtain their forms without delay from the Music Office, Education Department, Kowloon Central Post Office Building, 6th floor, Nathan Road, Kowloon in order to comply with the closing date of entry of the 20th January, 1968.

Entries for the Spring Practical Examinations of Trinity College of Music will close on the 31st January.

m.s. "Badenstein"

The m.s. "BADENSTEIN", fourth of seven new express liners of NORDDEUTSCHER LLOYD launched at Flenderwerke, Luebeck on 5th October 1967 joins her sister ships m.s. "FRIESENSTEIN", m.s. "HOLS-TENSTEIN" and m.s. "HESSEN-STEIN".

The BADENSTEIN (11.500 GRT) runs at a service speed in excess of 21 knots and is specially adapted for the Far East trade. All seven vessels of this new type are equipped with container facilities and a special car deck serves the purpose of carefully accommodating unpacked vehicles being loaded through sideports installed in the superstructure of the vessel.

Five holds are installed with a total capacity of 770.000 cbft. which includes refrigerator space of 29.000 cbft. 11 bulk liquid tanks, two of which are stainless steel tanks can carry 44.150 cbft. of liquid cargo.

Further a special chemical compartment of 8.000 cbft. meets the requirements of customers. Cargo handling equipment consists of 14 conventional derricks with a lifting capacity upto 10 tons and additionally 4 deck cranes will be fitted (lifting capacity of 30 tons is located between hatches 3 and 4 — a

further 80 tons derrick will be installed at hatch 2. The main propulsion unit is a MAN Diesel engine with 18.400 HP giving the full loaded vessel a speed of 21 knots plus.

New issue of Post Office Guide

A completely new issue of the Hong Kong Post Office Guide is on sale at all post offices at \$5 per copy.

It is in loose-leaf form and amendments are sent to purchasers at appropriate intervals on payment of a fee of \$1.

"The guide provides useful information about the post office services and charges and should be of interest to all firms having any significant amount of postal business, especially with other countries," a spokesman for the Post Office said yesterday.

Exporters List on Sale

A new edition of the Hongkong imports and exports classification list, which came into force as from January 1, is now available for sale.

Copies of this new edition, which incorporates the existing 1965 edition, as amended in 1966, as well as certain new amendments, will be obtainable from the Government Publications Centre at the Star Ferry concourse on Hongkong Island at \$5.50 each.

The imports and exports classification list is made up of two parts, a countries list and a commodities list. The commodities list is based on the United Nations Standard International Trade Classification, revised (S.I.T.C., revised).

The commodities list sets out the classified descriptions of some 2,500 items and the related code numbers under which goods imported or exported should be entered on all trade declarations before submission to the Commerce and Industry Department.

CMA Exhibition Closes with New Record

The Silver Jubilee Exhibition of Hong Kong Products sponsored by the Chinese Manufacturers' Association closed with a record attendance of 2m visitors, \$10m worth of sales at the fair and more than 1,000 overseas trade enquiries.

In a speech closing the fair which lasted 36 days, Mr. C. K. Choi, President of the CMA, said the exhibition was the best held so far, adding "this magnificent effort could only have succeeded through the cooperation of all concerned."

"Outdoor leisure in H.K."

A pamphlet in colour, "Outdoor Leisure in Hongkong," has been prepared by the Government Information Services Department describing the outdoor recreational facilities available here.

Copies are obtainable free from public enquiry centres, and distribution is also being made through schools, clubs, Kaifong associations, youth groups and public libraries.

Temporary Restriction on Imports of Knitted Coats, Jumpers. Cardigans, Sweaters and the Like Further to O.T.R. Circular No. 22/67 dated 9th September,

For the year ending 30th June, 1968, import licences are being issued to Australian importers on the basis of 100% of the value of imports in the year ending 30th June, 1967. Imports since 1st July, 1967 will be debited against these licences.

The above action is of a *temporary* nature pending full consideration by the Australian Tariff Board of the request by the Australian knitwear industry for additional protection. As far as the Department is aware, no date has yet been announced for the Tariff Board enquiry. Additional information is being sought and a further O.T.R. Circular will be issued when a Tariff Board enquiry has been announced.

Total Australian imports of the products concerned were worth A\$6.1 million in the year ending 30th June, 1967, of which A\$2.3 million were from Hong Kong.

Review of Protection Against Imports of Sand Boots and Shoes

The Department of Trade and Industry in Canberra is holding an enquiry regarding requests received from Australian industry for a review of protection and, pending the outcome of that review, temporary protection against imports of the following products:—

Interested parties, either in support of or in opposition to the request, have been invited to submit their views to the Department of Trade and Industry for consideration. The Department will submit results of the enquiry to the Minister of Trade and Industry who may then refer it to a Special Advisory Authority for enquiry and report. Any temporary protection which may be accorded on the recommendation of the Special Advisory Authority is in the nature of holding action pending Government consideration of the general question of protection for the Australian industry concerned following the usual enquiry and report by the Tariff Board.

Identification Marks For H.K. Manufactured Steel Bars

It was learned that identification marks will be required to be rolled onto steel bars during manufacture before they can qualify for Hong Kong origin certification.

The Certification Coordination Committee, which consists of representatives of the Hong Kong General Chamber of Commerce, the Federation of Hong Kong Industries, the Indian Chamber of Commerce, Hong Kong, the Chinese Manufacturers' Association and the Commerce and Industry Department, have decided on this move to protect local exports against possible substitution by foreign origin products.

The Committee has decided that, with effect from January 1, 1968, all round steel bars to be exported under Certificates of Origin issued by any member of the Certification Coordination Committee must bear the manufacturer's identification mark which should be registered for this purpose with the Commerce and Industry Department.

"All steel mills are, therefore, invited to register with the Commerce and Industry Department before January 1, 1968, any identification marks which they propose to roll onto their round steel bars for export under Certificates of Origin."

Certificates of Origin will not be issued for round steel bars which do not incorporate a registered identification mark after January 1 except (a) where it can be shown that the unmarked steel bars were manufactured before this ruling came into effect; and (b) where the Certification Coordination Committee gives prior approval to any member organisation to issue certificates for unmarked round steel bars. For example, in cases where a buyer stipulates that no physical markings should appear on round steel bars, the member organisation concerned will consult the Committee and approval will only be given for very exceptional reasons and on production of documentary evidence.

Exporters and manufacturers are therefore advised in their

own interest to consult the appropriate certificate issuing body before accepting such orders.

A team of inspectors from the approved certificate issuing organisations will visit registered steel mills at the end of December to record stocks of unmarked round steel bars.

Applications for certificates for these round steel bars will be accepted on a coordinated stock reducing basis.
