



China (Xiamen) International Fair for Investment and Trade 2019 cum Belt & Road Investment Congress (CIFIT & BRIC), endorsed by the State Council of the People's Republic of China, will take place on 7-8 September this year in Xiamen, China. CIFIT is currently Mainland China's only international investment promotion event aimed at facilitating bilateral investment. It's also the largest global investment event endorsed by the Global Association of the Exhibition Industry. "Belt & Road" is highlighted in CIFIT this year and a series of activities on related policies, facilities, trade and capital will be held at the fair.

CIFIT not only provides a comprehensive update on the investment environment, policies, projects and corporate products in Mainland China, but also attracts investment promotion agencies from more than 40 countries and regions.

The **Officiating Guest Country** this year is **Serbia**. Serbia has a modern industry that follows the business model of the free market. The tertiary sector is the largest sector in Serbia, accounting for 63.8% of GDP. To boost economic development, Serbia offers favorable tax incentives. For example, the corporate profits tax rate is only 10%, making it one of the lowest in Europe. The major source of export-import exchange is the EU countries, accounting for more than 50% of the total. The major export items are raspberries, corn and sugar.

Meanwhile, **Shanxi** is the **Officiating Guest Province**. Shanxi is the major base of energy sources in China with abundant reserves of coal, magnesium, bauxite and fireclay. In recent years, Shanxi has enhanced the traditional industries of coal, coke, metallurgy and electrical power while developing new pillar industries such as coal chemicals, new-energy vehicle manufacturing, equipment manufacturing, material manufacturing and tourism. In 2017, the major source of overseas investment was Hong Kong which accounted for 37.4% of the utilised FDI.
